

WAVE & GET XTRA HUAT CONTEST TERMS AND CONDITIONS

1.0 Wave & Get Xtra Huat Contest (“**Contest**”) is organised by **AEON BIG (M) SDN BHD (Company No. 199201011156)** (“**the Organiser**”) in collaboration with **PAYMENTS NETWORK MALAYSIA SDN. BHD. (“PayNet”) 200801035403 (836743-D)** (“**Prize Sponsor**”) from 2nd January 2020 until 31st March 2020 both dates inclusive (“**Contest Period**”) at all AEON BiG Hypermarkets nationwide.

2.0 By participating in this Contest, you expressly agree to be bound by all the terms and conditions below (“**Terms and Conditions**”).

3.0. Eligibility

3.1. This Contest is open to the cardholders of Automated Teller Machine (“ATM”) MyDebit Cards issued by MyDebit participating banks in Malaysia (“Participants”).

3.2. Participants must spend a minimum of RM80 using MyDebit contactless in a single receipt at any AEON BiG Hypermarkets (“Eligible Participants”). Eligible Participants may submit one (1) entry for each RM80 transaction in a single receipt (“**Receipt**”).

3.3. Eligible Participants must be a citizen or permanent resident of Malaysia who is currently residing in Malaysia and above 18 years of age on or before 2nd January 2020.

3.4. Eligible Participants must also have an account with any MyDebit participating banks in Malaysia which is valid, non-dormant and in good financial standing, during the Contest Period up until redemption of the Prizes.

3.5. The Organiser and PayNet’s employees (including its respective subsidiaries), agencies, dealers, distributors, sponsors and respective immediate family members are ineligible to participate in this Contest.

3.6. The Organiser reserves the right to reject any entries or disqualify any participant without assigning any reason whatsoever.

3.7. Participants are required to provide their complete personal information (name, mobile number, Malaysian Identity Card (MyKad/ MyPR) and email address) and complete a slogan in the Contest form made available at AEON BiG Hypermarkets.

3.8. Before the submission of Contest form into the designated Contest box, Participants are required to attach the original AEON BiG Receipt or payment terminal transaction slip (EDC slip) as the proof of payment via MyDebit contactless which payment must be made within the Contest Period.

3.9. For the avoidance of doubt, only the Contest form submitted within **the period of Weekly Xtra Huat** (Period: 2nd January – 26th January 2020) is eligible to be selected to win the Weekly Xtra Huat prize.

3.10. Contest forms that are incomplete, unclear and/or not satisfactory in any way howsoever will be disqualified at the Organiser’s sole and absolute discretion.

4.0. Prizes

4.1. A total of four hundred and seventy (470) winners will be selected by the Organiser and PayNet. The Organiser’s decision is final and binding and no appeals will be entertained. Each winner is eligible for one (1) prize only throughout the Contest Period and Prizes are listed as follows:

- 4.2. The Grand Prize of Toyota Corolla 1.8E A.T and First Prize of Toyota Vios 1.5E (AT) are excluding road tax, registration fee and insurance for Individual Private Registration in Peninsular/ East Malaysia. The colour of the Grand Prize and First Prize are final and non-negotiable. The winner shall bear all expenses to apply road tax, registration fee and insurance for the winning Grand Prize or First Prize.
- 4.3. The Organiser reserves the right to substitute the Prizes with other prizes of similar value without prior notice and without compensation.

5.0. Winners' Selection

- 5.1. The winners' selection will be conducted as follows:

- 5.1.1. **Weekly Xtra Huat** (Period: 2nd January – 26th January 2020) – All four hundred and forty (440) winners with the best slogan will be selected by the Organiser on weekly basis for four consecutive weeks ["Weekly Period"].

5.1.2. **Grand Reward** – All thirty (30) winners with the best slogan will be jointly selected by the Organiser and PayNet, and the winners of the Contest will be announced within three (3) months after the Contest Period ends.

5.2. **For Weekly Xtra Huat**, all winners will be contacted by the Organiser after every weekly draw took place and the Organiser will attempt to contact the shortlisted winners up to two (2) times via phone or email or through Short Message Service (SMS). The Organiser shall not be held accountable in the event if the shortlisted winners cannot be contacted for whatsoever reason and the Organiser has the right to select the next eligible winner by following the same procedure.

5.3. **For Grand Reward**, all winners will be contacted by the Organiser within three (3) months after the Contest Period ends and the Organiser will attempt to contact the shortlisted winners up to two (2) times during regular business hours (Monday to Friday) via phone. 5.4. The Organiser's decision in relation with, but not limited to the selection of winners and/or award of Prizes is final and conclusive, and no further correspondence, queries or appeals shall be entertained.

6.1. **Weekly Xtra Huat** – All winners for Weekly Xtra Huat will be arranged to collect at the nearest AEON BiG hypermarkets.

6.2. **Grand Reward** (Grand Prize, First Prize and Consolation Prize) – All winners for the Grand Reward are required to attend the 'Prize Giving Ceremony' to claim the prize, which the details of the event shall be confirmed by the Organiser. Any failure to attend the 'Prize Giving Ceremony' will cause the prize to be forfeited and the Organiser reserves the right to substitute with another winner.

By participating in this Contest, all Participants agree to release the Organiser and PayNet from any liability, losses, damages rights, and any kind of claims and actions in relation to this Contest and not limited to resulting from the acceptance, possession, use or misuse of the Prizes, or any Prizes-related activities taking into account, without limitation, injury, death, and property damage.

- 8.2. By Participating in the Contest, the Participants also give their consent to its bank to share their Personal Data and to the Organiser to collect their Personal Data including with third party (if required). All such third parties are contractually obliged, not to use the Participants' Personal Data in any other way than that stated herein.

- 8.3. The Participants may request for access to or correction of the Personal Data, submit enquiries or complaints, or limit the processing of their Personal Data at any time hereafter by submitting such request to AEON BiG via e-mail at dataprivacy@aeonbig.com.my. Please note that it will be necessary for us to process your Personal Data for the Purpose, without which you will not be able to participate in this Contest.
- 8.4. For the purpose of this Clause 8, all Personal Data relating to the Contest shall be governed and dealt in accordance with the Personal Data Protection Act 2010 and all other relevant laws in Malaysia.
