PayNet Direct Debit Mandate Display over HSBC Personal Internet Banking (PIB)

Dear Valued Customer,

Effective 18 November 2017, customers who have signed up for PayNet Direct Debit effective from 25 April 2011 onwards will be able to view the PayNet Direct Debit (DD) mandate on HSBC/ HSBC Amanah Personal Internet Banking.

What is PayNet Direct Debit?

PayNet Direct Debit is the authorization or mandate given by the Payer to the Biller to initiate the Inter-bank Direct Debit or collection transactions directly from Payers current/saving account and credit card account (excluding supplementary, debit and corporate card) to pay for recurring basis payment (eg. insurance, utility, membership fee, rental etc).

How to view PayNet Direct Debit mandate details via HSBC Personal Internet Banking (PIB)?

- **Step 1** : Login to HSBC PIB > Direct debit Mandate
