

## REVISION OF TAKAFUL COVER FOR HSBC / HSBC AMANAH CREDIT CARDS/-i, EFFECTIVE 11 JULY 2015

### A. Discontinuation of certain Takaful Cover

1. Effective 11 July 2015, HSBC Bank / HSBC Amanah are discontinuing some takaful cover for the following credit cards, summarised in the table below:
