AMENDED TERMS & CONDITIONS

HSBC Amanah Bose Gadgets 2025 PROMOTION ("Promotion")

PROMOTION PERIOD

- 1. HSBC Bank Malaysia Berhad (Registration No. 198401015221 (127776-V)) is referred to as "HSBC Bank" and HSBC Amanah Malaysia Berhad (Registration No. 200801006421 (807705-X)) is referred to as "HSBC Amanah" (collectively referred to as "HSBC").
- 2. Promotion Period runs from 1 January 2025 to 31 March 2025, both dates inclusive.

ELIGIBILITY

- 3. This Promotion is open to the following customers who are applying or currently holding HSBC Bank/HSBC Amanah Premier Account/-i and/or HSBC Bank/HSBC Amanah Premier Everyday Global Account/-i within the Promotion Period:-
 - (a) new HSBC Amanah Premier customers;
 - (b) existing HSBC Amanah Premier customers including:-
 - (i) inactive or dormant HSBC Amanah Premier customer(s) who re-activated their Premier status within the Promotion Period; or
 - (ii) existing HSBC Amanah customers who being upgraded to HSBC Amanah Premier within the Promotion Period,

("Eligible Customer(s)").

- 4. The following categories are **not eligible** to participate in the Promotion:

 - c. Permanent and/or contract employees of HSBC Bank Malaysia Berhad, HSBC Amanah Malaysia Berhad and other HSBC group entities in Malaysia.
- 5. Eligible Customer(s) whose Participating HSBC Amanah Products are not activated and/or delinquent, closed, and/or invalid/inactive, dormant, suspended, lost or cancelled during the Promotion Period or at the time of fulfilment of the rewards will not be eligible to join and/or receive any rewards under this Promotion.

PARTICIPATION CRITERIA

6. - 7. Eligible Customer(s), whether existing-to-bank (ETB) or new-to-bank (NTB), will have to maintain TRB of at least RM300,000 throughout the Promotion Period. For avoidance of doubt, TRB includes any Deposits in Premier Current Account/-i, Premier Savings Account/-i, Premier Time Deposits, Premier Term Deposits-i; AND/OR Investments in Unit Trust Funds/Shariah-Compliant Unit Trust Funds distributed by HSBC Amanah, HSBC Amanah Structured Product/-i, Sukuk distributed by HSBC Amanah.
- 8. The ETB Eligible Customer's TRB will be taken from the daily average of December 2024, as the starting baseline for this Promotion. The total incremental funds at the end of the Promotion Period (i.e. on 31 March 2025) will be accounted as 'Fresh Funds' to qualify for the Promotion.
