

## **TERMS AND CONDITIONS**

### **Organiser & Qualifications**

1. **" SPEND & WIN 28 HUAWEI P50 PRO & MORE WITH MYDEBIT ATM CARD "** **["Contest"]** is jointly organised by Watsons Personal Care Stores Sdn Bhd (Company No.: 199401004213 (289892 V)) and Payments Network Malaysia Sdn Bhd (Company No: 200801035403 (836743-D)) (PayNet) **["The Organiser"]**.
2. The Contest is open to all MyDebit Automated Teller Machine **["ATM"]** card holders issued by participating financial institutions authorising MyDebit services in Malaysia. The mentioned card holders must be a permanent resident in Malaysia or a Malaysian citizen who is 18 years of age and above and has a valid identification card during the Contest Period **["Participant"]**. The Participant must also have a valid account with any of the above mentioned financial institution in Malaysia and the account must be active with a good financial standing and not dormant during the entire Contest Period until the completion of the redemption of prizes.
