TERMS & CONDITIONS

Amended HSBC Premier Education Promotion 2021

1. HSBC Bank Malaysia Berhad (Company No. 198401015221 (127776-V)) will be referred to as ("HSBC Bank") and HSBC Amanah Malaysia Berhad (Company No. 200801006421 (807705-X)) will be referred to as "HSBC Amanah", collectively referred to as "HSBC".

THE PROMOTION PERIOD

2. The HSBC Premier Education Promotion 2021 ("Promotion") shall run from 23 July 2021 to 31 December 2021, both dates inclusive ("Promotion Period").

ELIGIBILITY

- 3. This Promotion is open to the following primary and supplementary credit cardholders of HSBC:
 - a. HSBC Bank Credit Card(s): HSBC Premier Travel Credit Card, HSBC Premier World MasterCard Credit Card
 - b. HSBC Amanah Credit Card-i(s): HSBC Amanah Premier World MasterCard Credit Card-i

(herein after referred to as the "Participating HSBC Credit Card/-i(s)")

EXCEPT for the following categories of persons:

- i. Cardholder(s) of HSBC Credit Card/-i(s) that are not issued in Malaysia; and/or

5. Once the Eligible Cardholder satisfies the Eligible Spend Criteria as per Clause 4 above in any Participating Months as per Table 1 below, the Eligible Cardholder stand to receive a RM150 Cash Back ("Cash Back"), subject to availability of the Cash Back allocation for that Participating Month on a first come, first serve basis, and the terms and conditions herein.

6. Only the **primary Eligible Cardholder** stands to win the Cash Back in this Promotion. Therefore, Eligible Spend made by the supplementary Eligible Cardholder(s) will be consolidated with the Eligible Spend made by the respective primary Eligible Cardholder.

Example: Cardholder A has a HSBC Premier Travel credit card, an HSBC Premier World MasterCard credit card and 2 supplementary HSBC Premier World MasterCard credit cards. All transactions on Eligible Spend made with all of those Participating HSBC/HSBC Amanah Credit Card/-i(s) will be consolidated and not viewed individually for this Promotion.

7. The tracking of the Eligible Spend is based on transaction posting date in Malaysia.

CASH BACK CONDITIONS

- 11. The Cash Back will be awarded to the **primary** Eligible Cardholder only. The maximum <u>Cash Back</u> a primary Eligible Cardholder may receive under this Promotion is three (3) units of Cash Back worth a total of RM450 throughout the Promotion Period, subject to the availability of the Cash Back for that Participating Month on a first come, first serve basis. There is a <u>maximum value of RM225,000 in Cash Back allocation</u> to be given out throughout the Promotion Period, which is pooled together with the HSBC Amanah Premier Education Campaign 2021.

where such notices shall be deemed to be effective on and from the 4th day after its delivery/publication/display as per the manner described herein. Save and except notices sent via ordinary mail which will be deemed delivered on the 3rd day after posting, notices sent via other modes as described herein are deemed delivered immediately after posting/publication/display.

These Terms and Conditions are in addition to the respective Universal Terms and Conditions ("UTCs") for HSBC of which the respective Cardholder Agreements are a part of and which regulate the provision of credit card/-i facilities by HSBC. The UTCs are available at www.hsbc.com.my and www.hsbc.com.my. In the event of inconsistency between these Terms and Conditions and the UTCs, these Terms and Conditions shall prevail in so far as they apply to this Promotion.

- 24. The Eligible Cardholder shall be personally responsible for all taxes, rates, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to this Promotion.
